Motion to approve the 2018 budget hearing minutes made by Paul, 2<sup>nd</sup> by Kelley. Motion passed.

Ashley noted she received the Wipfli contract for financial audit services and the budget hearing notice reflected the contract amount.

## Town of Sherman Special Meeting November 20, 2019

Chairman Chase Potter called the Special meeting of the electors to order at 6:25pm. Chase provided the UW Extension's definition of a special town meeting and the intent to approve the 2019 Town of Sherman Levy payable in 2020 and compensation for elected town officials to be elected April 21, 2020 for two-year terms.

Sarah Paquette made the motion to approve the tax levy payable of \$189,160.00 2<sup>nd</sup> by Kelley, Motion passed.

Chase noted that after 2015 highway expenditures need not be voted on at a special meeting of the town electors.

Discussion on raising the compensation for Supervisors 3 and 4 by the inflation rate of 2% per year. Current gross salary for Supervisors is \$2,667.00. James Paquette made the motion to increase the Supervisor 3 and 4 wages to a gross of \$2,773.68 per year for term held April 2020-April 2022, 2<sup>nd</sup> by Luann Paquette. Motion passed.

Chase asked if there was any other business to discuss. There was none.
