Motion to approve supervisor #3 and Supervisor #4 positions salaries at \$3,025.00 for two-year terms beginning April 2022 to April 2024 made by Chase, 2nd by Paul. Ashley called role call vote as follows: Paul-yes, Amanda-no, Lynn-yes, Kelley-no, Terry-abstain, Mitchell-no, Ed-yes. Motion passed with 4 in favor, 3 opposed, and 1 abstain.
