MONTHLY BOARD MEETING
February 15, 2023

Chairman Chase Potter called the February 15, 2023 Monthly Board Meeting to order at 6:32p.m and stated that the meeting had been properly noticed and published.

Chairman Potter asked if there were any additions or corrections to the minutes from the January 18, 2023 monthly meeting. Paul made the motion to approve the January meeting minutes as presented, 2nd by Amanda, motion passed.
