MONTHLY BOARD MEETING  
July 12, 2023

Chairman Chase Potter called the July 12, 2023 Monthly Board Meeting to order at 6:30p.m and stated that the meeting had been properly noticed and published.

Those present were Chairman Chase Potter, Board Members, Amanda Klosterman, Sherri Vodinelich, Kelley Krause, Lynn Smith, Clerk/Treasurer Ashley Score, and Patrolman Terry Ford. Refer to sign in sheet for others present.

Chairman Potter asked if there were any additions or corrections to the minutes from the June 21, 2023 monthly meeting. Kelley made the motion to approve June meeting minutes as presented, 2<sup>nd</sup> by Amanda, motion passed.

Public input – Dave Rheasler spoke regarding his concerns in needing dust control on Buckeye Road and possible alternative options for traffic control.

Ashley provided the Clerk/Treasurers report of correspondence including delinquent solid waste and recycling notices were sent and additional payments have been received. Motion to approve the July payments for approval check detail made by Kelley, 2<sup>nd</sup> by Amanda. Motion passed.

Building permits- Chris Moulder for a ‘tree’ house.

Driveway permits- There were none.

Utility permits-There were none.

Ashley shared the information and monthly charge for adding internet and phone service to the Town hall building from Spectrum Charter. Motion from Amanda to approve spectrum internet and phone service for town hall, 2<sup>nd</sup> by Lynn. Motion passed.

Sherri provided a cemetery sexton update noting she sent out the cemetery informational mailing and updated to the cemetery records based off the actual cemetery headstones.

Chase shared the price per ton for asphalt in 2020 verses the price per ton for asphalt in 2023, noting an increase of approximately 61%. Discussion on public works budget road maintenance for 2023 and waiting to see if asphalt prices decrease in 2024 for capital improvement projects.

No update from Boyceville Fire and Ambulance.

No update from plan commission. Next meeting is scheduled for August 2, 2023.

Terry provided an update on road work including ditch mowing and tree trimming.

August monthly meeting is scheduled for Wednesday, August 9, 2023 at 6:30pm. September monthly meeting is scheduled for Monday, September 18<sup>th</sup> at 6:30pm. October budget planning meeting was scheduled for Wednesday, October 18, 2023 at 6:00pm with October monthly meeting to immediately follow.
